Apologies were received and accepted from Cllrs Falder, Meyrick and Ford

12/59 Variation of Order of Business

No items were identified that required the order of business to be varied

12/60 Declaration of Interests:

No declarations were made.

12/61 Public Speaking

a) Members of the Public and council to comment on any matter

Mr Toone reported on the latest Neighbourhood Watch meeting which was very well attended. He reported that residents had shown considerable interest in setting up a Community Speedwatch on Bretby Lane and he has 12 volunteers ready to undertake the necessary training. The mechanics of the scheme were explained to the meeting. The residents of Oldicote Lane have joined NHW and there is significant interest shown from residents of Ashby Road East to join NHW, but another co-ordinator is required before additional members can be accepted.

Cllr Smith explained the success of the Community Speedwatch scheme at Hartshorne. He added that he has received the training and offered his assistance and support and urged for the scheme to be pursed. The Parish Council expressed their support for the Community Speedwatch Scheme.

Mr Toone reported a number of large posters being erected on BT boxes, advertising BT fibre broadband and enquired if these had received any necessary permission. Cllr Stanton offered to make enquiries with the planning dept regarding this.

b) Police, County Council and District Council members to raise any relevant matter

Cllr Smith advised that the Local Development Framework (LDF) consultation ends soon and recommended that people participate in the consultation exercise. Cllr Stanton concurred, stating it is important that people attend the consultation events provided by SDDC and provide their opinions.

Cllr Smith reported that there had been a spate of flytipping involving tyres and advised that the Clean Team will only remove flytipping from public land. Any flytipping on private land is for the landowner to remove.

With the delivery of the salt, it was considered that a decision is made regarding the grit box which was removed from Bretby Lane earlier in the year. The Parish Council considered various locations, but reached no decision. The grit box will remain in storage for the immediate future and the matter will be considered at the next meeting.

The Clerk reported that the noticeboard on The Green would benefit from some general maintenance.

RESOLVED: accept Cllr Badger's offer to clean and carry out routine maintenance of the noticeboard. Thanks were given to Cllr Badger.

There had been a few misunderstandings expressed about the County Council's street lighting proposals, but Parish Councillors and the Clerk had rectified these. The proposal is to take effect in November, but to date, the scheme has not been implemented.
